### GENERAL INFORMATION, ALSO SPECIAL REGULATIONS & CONDITIONS OF ENTRY

**LOCATION** – The sale will be held at Newark Livestock Market, Great North Road, Newark, Nottinghamshire NG24 1BY

**CONDITION OF SALE** - The Sale will be held under the Auction Rules and Conditions of Sale drawn up by the N.B.A. The Sales will be held subject to these rules and the Auctioneers' General Conditions of Sale, both available on request. In the event of any discrepancy between the two sets of conditions, the N.B.A. Conditions of Sale shall prevail.

**METHOD OF SALE** – All pedigree cattle will be sold in guineas (105 pence) with a commission rate of 5% and in catalogue order, unless any alterations are announced by the auctioneers at time of sale.

**PRE-SALE SHOW CLASSES** - The classification will be decided and sub-divided into appropriate age groups after the entries have closed.

**ENTRY FEES** – Society Show & Sale: an entry fee of  $\pm 25 \pm VAT$  per animal ( $\pm 30.00$ ) must be submitted with all entry forms. Calf Show & Sale: an entry fee of  $\pm 15 \pm VAT$  per animal ( $\pm 18.00$ ) must be submitted with all entry forms. Good quality photographs of lots can be added to the catalogue at a cost of  $\pm 25 \pm VAT$  ( $\pm 30$ ), please email them to heatherp@borderway.com.

All entry forms must be accompanied by the entry fee and the relevant Longhorn Cattle Society Registration Certificates. Entries without the relevant fees and certificates will not be accepted. The Society reserves the right to refuse or restrict entries if it is felt necessary, at the closing date for entries.

SALE ORDER - Female cattle in age order, followed by bulls, followed by calves.

The Society reserves the right to inspect entries prior to the Sale to assess their suitability.

There will be three sections:

- a) A section for led and shown cattle
- b) A section for sale only cattle must be led
- c) A section for calves

All calves entering class 6

- Must be birth notified or registered with the Society.
- Must be weaned and haltered
- · Must comply with the appropriate health regulations
- Calves purchased at this event will be eligible for entry into the Multibreed Calf Show at Newark on 10 November 2019.

Entry of Classes 1-6 is open to any full member of the Society provided their subscriptions are up to date and all stock must be fully registered or notified within the Society's official notification of birth time limit.

Disbudded cattle may be shown at Society Sales.

**HEALTH** – Vendors are encouraged to belong to a CHeCS approved health scheme. Members must apply to their Health Scheme Provider for an animal health declaration card prior to the sale and send a copy to the Office. All animals forward for sale must comply with the requirements of the Health Delcaration Form (see enclosed) and the form must be returned with the entries.

**Pre Movement TB Testing** - All cattle over 42 days of age must have passed a TB test within the previous 60 days of the movement. All cattle from England, Wales or Scotland **must be** pre movement tested, irrespective of TB testing area.

The vendor must present for sale by Auction any animal catalogued for sale. Where animals catalogued cannot be brought forward a 'like for like' substitution can be made up to 48 hours prior to the start of the sale. Should a substitution be made then a veterinary certificate should be submitted for the withdrawn animal and a  $\pm$ 50+VAT ( $\pm$ 60.00) fee will be payable for the entry of the substitute animal.

**TRANSFER FEE** – a fee of  $\pm 15 + VAT$  ( $\pm 18.00$ ) shall paid by both the vendor and the purchaser. Pedigree certificates will only be transferred on payment of the transfer fee.

STRAW – will be provided by the Auctioneers at a charge of £4 per bale.
